RULES

- ☛ **All fencers must have a valid CFF License to participate in this tournament.** Ontario fencers must also have an OFA Competitive Membership or an OFA Youth Competitive Membership.
- ☛ *Under 17* – Birth date after January 1, 1991
- ☛ *Under 15* – Birth date after January 1, 1993
- ☛ *Under 13* – Birth date after January 1, 1995
- ☛ *Under 11* – Birth date after January 1, 1997
- ☛ *Under 11 Format:* mixed format, pools of 5, 6, or 7 to 3 points (2 min.) with no fencers eliminated, then direct elimination (5 points (3 min.)), final of 7 points (2 periods of 2 min. with 1 min. rest).
- ☛ *Under 13 Format:* pools of 5, 6, or 7 to 5 points (3 min.) with no fencers eliminated, then direct elimination and finals to 8 points in foil and épée and 10 points in sabre (2 periods of 3 min. with 1 min. rest).
- ☛ *Under 15 and Under 17 Format:* pools of 5, 6, or 7 to 5 points (3 min.) with no fencers eliminated, then direct elimination and finals to 15 points (3 periods of 3 min. with 1 min. rest) (Time permitting).
- ☛ This competition will be run in accordance with FIE Regulations of Competition. All participants are subject to Section t.15 of the FIE rules.

EQUIPMENT CHECK

Masks at registration, other equipment on the piste. Fencing jacket and sous-plastron, or FIE approved jacket is required. Fencing pants are required for 'Under 17' events. Electric Sabre will be conducted in the 'Under 15' and 'Under 17' events only.
