*Under 15* – Birth date after Jan. 1, 1994

⚔ *Format:* minimum of one round of pools of 6, 7, or 8 to 5 points (3 min.) with no fencers eliminated, then direct elimination 15 points (3 periods of 3 min. with 1 min. rest).

⚔ **All fencers must have a valid Provincial Membership and CFF License to participate in this tournament.**

⚔ This competition will be run in accordance with FIE Regulations of Competition. All participants are subject to Section t.15 of the FIE rules.

⚔ Complete fencing outfit (no track pants), sous-plastron, and electric equipment are required. Equipment check will be done on the piste.
